Basic Needs/Safety Net Services Fund to add one (1) part-time CHA Low-Income Services Independent Living Coordinator; and the Execution of the Contract Award Agreement and Implementation of the Programs

as Described in the Application.

The Heart of Missouri United Way employs a community impact model to award funding which addresses the four key targets that contribute to poverty: lack of access to education, health, financial stability and basic needs/safety net services. On December 11, 2017 the United Way began soliciting proposals from agencies to provide social services that address issues related to Basic Needs/Safety Net Services.

The Heart of Missouri United Way Basic Need/Safety Net Services fund supports crisis and intervention services, which include:

- Basic needs (food, clothing, shelter, etc.)
- Personal safety services for individuals and families who face threats to their immediate well-being, including, but not limited to domestic violence, child abuse and sexual assault
- A coordinated system of information and referral services

As CHA Low-Income Services supports the full mission of the Columbia Housing Authority which includes helping elderly and individuals living with disabilities to live independently, CHALIS seeks to expand services offered to the elderly populations living in the Oak Tower Apartments. Currently one full-time Resident Services Coordinator serves all residents living in Paquin and Oak Towers. The population requires a high level of service, especially when change occurs, such as recently experienced with the conversion and remodeling of the apartments.

CHA Low-Income Services, Inc. seeks approval to submit an application to the Heart of Missouri United Way in an amount equal to the cost of adding one part-time Independent Living Coordinator who will be designated to serve the individuals living in the Oak Tower Apartments for a period up to two years. The part-time position would provide case management and coordinated service referral to help Oak Tower residents meet basic needs, build a sense of community, and continue to live independently as they adjust to new systems and neighbors.

Staff Recommendation: Adopt Resolution 99 to authorize the submission of an application to the Heart of Missouri United Way 2018 Basic Needs/Safety Net Services Fund to add one part-time CHA Low-Income Services Independent Living Coordinator; and authorize the Execution of the Contract Award Agreement and implementation of the programs as described in the application.

Application.

The Heart of Missouri United Way employs a community impact model to award funding which addresses the four key targets that contribute to poverty: lack of access to education, health, financial stability and basic needs/safety net services. On December 11, 2017 the United Way began soliciting proposals from agencies to provide social services that address issues related to Education Services.

The Heart of Missouri United Way Education Services fund supports school readiness, literacy and academic success. Through this funding United Way works to increase the number of youth who:

- Enter school ready to succeed.
- Read proficiently by 3rd grade.
- Make a successful transition in and out of middle school.

As CHA Low-Income Services supports the full mission of the Columbia Housing Authority which includes helping youth succeed, CHALIS seeks to enhance services offered to the students enrolled in its Moving Ahead Afterschool and Summer Program through an intensive early reading program.

The Moving Ahead Program serves 100 children from low income households in grades K-12. With the first few months of the 2017-2018 school year completed, staff serving grades K-3 have observed that nearly 50% of the students are below the desired reading level for their grade. The Kindergarten Classroom teacher states that several Kindergarten students are even unable to identify the letters in the alphabet.

With this urgent need, CHA Low-Income Services, Inc. seeks approval to submit an application to the Heart of Missouri United Way for funding to support an intensive and rigorous reading program designed to help students in grades K-2 achieve third grade reading level by the end of second grade. If approved, the funding would support this with one year of funding, plus two one-year renewal opportunities for a total of 3 years of support. The intensive reading program is being developed in collaboration with the Columbia Public Schools. If funded, programming could begin this summer to prepare children for the 2018 - 2019 school year.

Staff Recommendation: Adopt Resolution 100 to authorize the submission of an application to the Heart of Missouri United Way 2018 Education Services Fund to support the Moving Ahead Afterschool and Summer Program intensive early reading program and authorizing the execution of the contract award agreement and implementation of the programs as described in the application.

RE: Resolution 101: A Resolution to Approve the Submission of a FY2018 Community-Based

Coalition Enhancement (CARA) Grant to Address Local Drug Crises to the Substance Abuse and Mental Health Services Administration to prevent and reduce the abuse of opioid,

methamphetamines and prescription medications among youth aged 12 – 20 in Columbia.

Background Information:

The Executive Office of the President, Office of National Drug Control Policy (ONDCP) and the Department of Health and Human Service (HHS), Substance Abuse and Mental Health Services Administration, Center for Substance Abuse Prevention (CSAP) are accepting applications for FY2018 Community-Based Coalition Enhancement Grants to Address Local Drug Crises funded through the Comprehensive Addiction and Recovery Act (CARA). The purpose of this program is to prevent and reduce the abuse of opioid and methamphetamines, and reduce the abuse of prescription medications among youth age 12-20 in communities throughout the United States.

The CARA program was created to enhance the ability of established community organizations to create community-level change; strengthen collaboration among communities, the federal government, state, local, and tribal governments; enhance intergovernmental cooperation and coordination; and develop a comprehensive community-wide action plan to reduce the use of opioids or methamphetamines and the abuse of prescription medications among youth within the area served by the coalition.

CHA Low-Income Service's grant request will be for approximately \$50,000 per year for up to 3 years. The Youth Community Coalition shall operate under CHA Low-Income Services, Inc. to coordinate the services and activities outlined in the grant application and conduct grant activities in accordance with the strategic plan of the coalition. The Youth Community Coalition is experienced in evidenced based programming and prevention. Additionally, the Coalition has a successful history of capacity building in the community and a network of partners and resources to fully complete the strategies of the grant application.

WHEREAS, the Youth Community Coalition is a community-based coalition of youth and adults, designed to prevent substance abuse, underage drinking, teen pregnancy, and teen homelessness, and seeks to build capacity among community organizations to address these issues; and

WHEREAS, the Youth Community Coalition shall operate under CHA Low-Income Service, Inc. to coordinate the services and activities outlined in the grant application, sub-contract, or partnership and conduct those activities in accordance with the strategic plan of the coalition; and

BE IT FURTHER RESOLVED that the Board of Directors of CHA Low-Income Services, Inc., hereby adopts Resolution 101 authorizing the submission of a CARA grant application up to \$50,000 per year, for up to three years, to the Substance Abuse and Mental Health Services Administration; and

BE IT FURTHER RESOLVED that if the CARA grant application should be approved, Resolution 101 also authorizes the execution of all applicable grant contract award agreements and the implementation of the programs and projects as described in the grant application.
