I. Call to Order and Introductions:

Renovations at Oak Towers are figured to be complete Mid July 2018, Bryant Walkway II December 2018 and Bryant Walkway I Summer 2019. With the new renovations comes better living conditions for our residents.

Discussion of Future Meeting Topics:

Mr. Steinhaus asked the Residents if they had any topics they would like to discuss at the next meeting. In which they stated they would like to discuss elevator etiquette and concerns they had regarding overfilling of the elevators. Mr. Steinhaus stated the elevators were equipped with sensors that would not allow the elevator to move if they were over the weight limit.
