#### **Executive Summary**

The proposed 2024 CHALIS Budget for Fiscal Year January 1, 2024-December 31, 2024, presented here reflects an estimate for the 2024 budget year.

ILP (City) – City Independent Living Program

#### Discussion

#### **Revenues:**

- Federal Grants total \$623,633, County Grants total \$316,308, City Grants total \$90,193, Local Grants total \$56,797 and Rental and Other Income total \$84,597 for a full budget of \$1,171,528.
- In 2023, CHALIS was awarded a five-year 21<sup>st</sup> Century grant beginning September 1, 2023. The 21<sup>st</sup> Century ESSER funding award was completed in August 2023. The 21<sup>st</sup> Century budget is broken down into the two grant periods covered during 2024. The 2023 column includes what we estimate will remain at the end of this year for the first-year funding to be used through June 2024. The 2024 column is funding for the second half of 2024 and represents one half of the year 2 budget less a \$26,320 carryover to 2025.
- The Columbia Public Schools ESSER III funding grant period ends on June 30, 2024. The budget reflects an estimate of the amount remaining to carry over to 2024.
- County grants, City grants, and United Way grant funding amounts are unchanged from the current year.

#### **Expenditures:**

- Salaries increases are budgeted for current staff and two full-time positions have been added.
- Health and dental Insurance costs are budgeted with an increase of 8 percent.
- Contracted Services provide educational speakers to bring programming in-house to the Moving Ahead Program.
- Professional development is required for the Moving Ahead staff to complete their annual clock hour requirements for teaching.
- Program expenses provide programming supplies, food, and supplies required for licensing.

#### Moving Ahead Program (MAP)

- The MAP program includes several funding sources: 21<sup>st</sup> Century, CPS ESSER, MAP County, City MAP, and Heart of Missouri United Way total estimated funding from all sources is \$795,475.
- The budget includes salary increases for current full-time and part-time staff.
- The budget includes the addition of two full-time positions to function as program support coordinators.
- The budget includes increasing two part-time positions to 28 hours per week and changes their position title to Lead Teacher.
- One part-time staff member included in the budget splits their time between the roles of kitchen assistant and van driver for the MAP program.
- The budget also includes 10 part-time teachers working 17 hours per week. There is no health insurance or retirement budgeted for these staff, apart from two active staff currently enrolled in the retirement plan.
- The Data Coordinator position is allocated as a .5 FTE to the Moving Ahead Program.
- There is \$145,978 allocated for program supplies and \$30,216 for Contracted Services in 2024. This is a 14% increase from the 2023 budget and is available because of the increased 21<sup>st</sup> Century funding awarded.

#### Child and Adult Care Food Program (CACFP) and Summer Food Service Program (SFSP)

- Includes one PT staff Kitchen Manager
- The budget allows for about \$1,000/week for food and food supplies purchases.
- The CACFP program provides a healthy after-school snack and dinner each day for each MAP student attending the program during the school-year months. The SFSP program provides breakfast and dinner each day for the students who attend the summer MAP program.

#### **Healthy Home Connections (HHC) Program**

- Three FT resident services coordinators are split between HHC, City Independent Living Program and LIHTC funding = 2.55 FTE is allocated to HHC.
- .25 FTE of the Data Coordinator position is allocated to grant.
- About ½ of health insurance benefits are allocated to the LIHTC funding based on grant funding restrictions.
- Program expenses are budgeted to assist tenants with their basic needs.

#### City Independent Living (ILP) Program

- Three FT resident services coordinators are split between HHC, City ILP and LIHTC funding = .45 FTE is allocated to City ILP.
- .25 FTE of the Data Coordinator position is allocated to grant.

#### **LIHTC funding**

- This revenue is unchanged from the 2023 funding.
- Funding is received from Stuart Parker (84 units), Bear Creek (76 units), Bryant Walkway (54 units), and Bryant Walkway II (36 units) to cover the time spent by the three FT resident services coordinators serving these tenants.

#### **CHALIS General**

- Includes 30% of the Director of Resident Services, 40% of the CHALIS Accountant, and 10% of the HR Manager and IT Coordinator.
- Vehicle maintenance and insurance not covered by grant funding is allocated here.
- Liability insurance and audit costs will be charged to CHALIS General and allocated to the various grants where allowable as an indirect cost.
