• CCHT will maintain a long-term interest in the project with a secondary lien and have a first right of refusal to purchase upon the owner notifying a desire to sell. A promissory note, deed of trust and related documents were drafted by CHA attorney and outline transaction procedures for the participant and CHA.

Proceeds from the sale will remain in the CCHT Reserve account for future development of affordable housing for qualifying populations in accordance with CCHT's 501c3 status.
