Re: **Resolution 149**: to Approve the CHA-Low-Income Services, Inc. (CHALIS) IRS 990 Form Submission for FY 2024.

Executive Summary

The attached resolution authorizes the FY 2024 990 form submission to the IRS for the CHA Low-Income Services, Inc. (CHALIS).

Discussion

CHALIS continued supporting CHA's mission throughout calendar year 2024 to provide programming activities, resources, and referral services designed to help children succeed in school and in life, support families working toward self-sufficiency, and assist elderly and disabled residents in living independently.

CHALIS maintained a broad range of resident support programs funded through contributions and service revenues totaling \$1,110,161. Program expenses for CY2024 totaled \$1,130,793. The form notes revenue less expenses of (20,632), however \$18,886 of expenses is depreciation associated with McBaine Townhomes. CHALIS ended the year with net assets of (\$203,909).

CHALIS served youth, families, seniors, and people with disabilities, providing structured support that ranged from academic and enrichment services to referrals and self-sufficiency resources. These offerings reflect long-standing core services, and no significant new programs or program discontinuations were noted.

FY 2024 reflects steady program activity, solid contribution revenue from community partners, and continued alignment with CHALIS's charitable purpose of enhancing resident stability, opportunity, and quality of life.

Approve the resolution authorizing the FY 2024 990 form submission to the IRS for CHALIS.
